



Enviromental management system

Primetec Sweden AB aims to comply with the principles behind ISO 14001:2015 but has not undergone the certification process. Undergoing this is in the development plan which extends until 2025.

Primetec Sweden AB have therefore decided to do everything we can to work in a sustainable manner, and by doing so -meet all the environmental requirements specified in ISO 14001: 2015.

The first part of our enviromental action plan has been to describe and document existing routines and introduce new routines regarding:

- Equipment (electricity consumption, service etc.).
- Transport (environmental friendly partners, better planning - no extra transports etc.).
- Waste management (in the field and in the office/warehouse).
- Service cars (all company cars must be at least hybrid -electric/petrol)

Equipment

Our mission is to always use high end equipment that has the least possible environmental impact, this applies to both product development, electricity consumption as well as service. In all purchasing processes, the environmental impact must be taken to account in terms of equipment selection.

Transport

Our mission is to have a detailed plan for all our projects so that extra transports will never be required. We also, to the best of our ability, use transport companys that have an environmental policy in place.

Waste management

Primetec Sweden AB and all employed by the company shall ensure that all consumables such as packaging materials, batteries, bulbs and other materials are recycled. It is our responsibility to ensure that waste management is available at all venues, arenas or facilities where we work.

Service cars

All company vehicles that Primetec provide to employees need to be “super environmental cars” at the very least hybrid (electric/petrol).
